### Civic green building program

#### **Leading by example**

- If we can achieve certification for our own civic buildings – a trend is set for others to follow
- High performing buildings benefit the Community
- More control over actions and accomplishments

#### Green building programs for <u>new</u> <u>development</u> - things to consider...

- Inventory existing policies, programs, codes i.e. LEED, Green Globes
- Analyze current and projected building trends
- Evaluate and amend existing guidelines and programs
- Governmental mechanics of how to implement a successful program
