EPA Proposed GHG Reporting Rule

- Mandatory monitoring and annual reporting for stationary sources that emit 25,000 metric tons of CO₂e in any year starting in 2010
- Annual reporting for fossil fuel suppliers and engine manufacturers
- Focus on stationary fuel combustion sources and list of industry specific sources that emit GHGs
- EPA estimates applies to 13,000 facilities, but an additional 17,000 will need to calculate emissions to determine whether they fall under rule



EPA Proposed GHG Rule (con't)

- Notable items
 - Perpetual 114 information request
 - Facility level reporting for stationary sources
 - Once in, always in
 - 30 mmBtu/hour presumption
 - CEMS; default values
 - "Emergency generators" don't count
- Reporting requirements under rule may kick in before federal or state emission reduction programs – how does this affect compliance approach?



EPA Proposed Endangerment Finding

- Latest EPA Response to Mass. v. EPA
- 6 major GHGs are reasonably anticipated to pose a danger to public health and welfare
- Finding under 202(a), but could it have effect on other CAA programs?
- Message to Congress: "if you don't do something, we will"



Obama February Budget Proposal

- Economy wide cap and trade
- 14% below 2005 levels by 2020
- 83% below 2005 levels by 2050
- 100% allowance auction
- \$646 billion in revenue between 2012 and 2019
- Congressional agreement creates a "reserve fund" to implement cap and trade program



American Clean Energy & Security Act of 2009 (Waxman – Markey)

Clean Energy

- □ Federal RPS; 6% by 2012, 25% by 2025
- Carbon capture and storage and coal plant performance standards

Energy Efficiency

- Buildings, appliances, transportation
- Mandatory demand side management for utilities
- Transition to Clean Energy Economy
 - Green jobs, consumer assistance



An Environmental and Energy Law Practice

ACES Act of 2009 (con't)

- Cap and trade program for GHGs
 - 20% below 2005 levels by 2020; 83% below 2005 levels by 2050
 - Stationary sources emitting 25,000 tons per year CO₂e; producers and importers of petroleum fuels; natural gas sellers and other GHG producers
 - Offsets allowed 1 to 1.25; 1 billion tons domestic, 1 billion tons international
 - Carbon market oversight by FERC
 - Excludes regulation of GHGs as HAPs, criteria pollutants or under NSR
 - State and regional trading programs suspended between 2012 and 2017
 - Auction vs. allocation to be decided later
- Hearings last week; markup postponed

Cap and Dividend (Van Hollen)

- capped at 2005 levels in 2012; 85% below 2005 levels by 2050
- Cap is on fossil fuel suppliers, not emitters
- 100% auction
- proceeds distributed to US citizens
- Republican response?



State and Regional Developments

- Regional Greenhouses Gas Initiative (RGGI)
 - Cap and trade program for EGUs in 10 Northeast and Mid-Atlantic states
 - Effective January 1, 2009
 - Offsets: initially limited to 3.3%; only 5 types
 - Landfill methane capture and destruction
 - SF6 reductions
 - Afforestation
 - End-use efficiency
 - Agricultural manure management
 - Auctions began in September 2008
 - Price between \$3.05 and \$3.51



Pennsylvania Climate Change Act (Act 70)

- Establish Voluntary GHG Registry
 - Emissions: Climate Registry
 - Offsets: Climate Action Reserve, Voluntary Carbon Standard, Gold Standard
- Impacts Assessment
 - Draft report released April 17; 30 day comment period
- Annual Inventory and Baseline
 - Due with Climate Change Action Plan
- Climate Change Advisory Committee



Act 70 Climate Change Action Plan

- Study dozens of proposed "work plans"
- 5 subcommittees
 - Electricity Generation, Transmission and Distribution
 - Industry and Waste
 - Residential and Commercial
 - Land Use and Transportation
 - Agriculture and Forestry
- Contractor: Center for Climate Strategies
- Public review and schedule remain issues
 SB 829 (White)



An Environmental and Energy Law Practice

New Jersey Global Warming Response Act

- 1990 levels by 2020; 80% below 2006 levels by 2050
- DEP charged with producing a report on actions needed to achieve 2020 and 2050 limits
- DEP issued draft report in December 2008
 - B 3 programs in place EMP, LEV program & RGGI will achieve 2020 limit
 - Lists additional statutory, regulatory and policy efforts to be taken over next 18 months to ensure 2020 limit is met and set groundwork for 2050 limit
 - Outlines "framework" that should be moved forward to achieve 2050 limit
 - Comment period closed; final report pending



Carbon Capture and Sequestration

Capture and compression

- Supercritical liquid
- Transport via pipeline to storage site
- Injection into storage formation
 - Unused oil and gas wells
 - Unmineable coal seams
 - Deep saline groundwater formation
 - 800 meter bgs

CO₂ has been injected for commercial EOR since 1972



Carbon Capture and Sequestration

Number of operational, regulatory and legal issues are unresolved

- Commercial feasibility
- SDWA UIC proposed rule
- Other regulatory programs
- Pore space ownership
- Tort liability/protection
