He serves as a master emeritus of the Delaware Valley Environmental Inn of Court, served two terms as a member of the Board of Directors of the Pennsylvania Bar Institute, and serves as a member of the Pennsylvania Environmental Hearing Board Rules committee. Manko was appointed by the Montgomery County Board of Commissioners to serve on the County's Task Force on the Reduction of Greenhouse Gas Emissions. His longest position was to serve as Commissioner to Lower Merion Township for 27 years until his retirement in 2006, making him the Township's longest serving elected official. In 2007, he had an appointment by Governor Tom Ridge to serve on Pennsylvania's 21st Century Environment Commission.

Professionally, Manko is known for his extensive knowledge and practice of environmental law, focusing in sustainability initiatives, environmental reporting and alternate dispute resolution.
