## **Neil S. Witkes and Nicole R. Moshang Serve as Panelists on “Indemnity and Insurance: Getting the Most Out of Your Contract Indemnity Provisions and Filling Gaps in Potential Exposures” for DELVACCA’s CLE Institute**
