On January 1, 2010, the U.S. Environmental Protection Agency will, for the first time, require large emitters of heat-trapping emissions to begin collecting Greenhouse Gas (GHG) data under a new reporting system. In addition to providing an in-depth analysis of how to navigate the components of the new Greenhouse Gas Reporting requirements, Kantorczyk and fellow speakers will address topics including "Climate Change Regulatory Update"; "Applicability: Is My Facility Included? Or Can I Opt Out?"; "Integrating Mandatory and Voluntary Reporting"; "Emissions – Monitoring, Plans, Calcs & Reports"; and "Emissions Offsets – Can I Generate Them?"
