## MICHAEL M. MELOY OF MANKO, GOLD, KATCHER & FOX, LLP ON A PANEL DISCUSSING "CLIMATE CHANGE: NEW THINKING FOR NEW WEATHER" AT THE UNIVERSITY OF DELAWARE INAUGURAL FORUM

Philadelphia, PA (May 8, 2008) – Michael M. Meloy has 25 years of experience in the environmental field. He uses his legal and engineering background to assist clients in connection with a broad spectrum of environmental litigation, regulatory and transactional issues, including shaping and complying with environmental regulatory requirements. Meloy serves on the Pennsylvania Cleanup Standards Scientific Advisory Board and the Delaware Basin Regional Water Resources Committee. He chairs the Solid Waste Advisory Committee for the Pennsylvania Chamber of Business and Industry and chaired the Agricultural Law Committee of the Pennsylvania Bar Association. He is also a member of the Advisory Council of the Department of Civil and Environmental Engineering at the University of Delaware.
