MICHAEL MELOY AND BART CASSIDY OF MANKO, GOLD, KATCHER & FOX, LLP TO SPEAK AT ENVIRONMENTAL ROADSHOW

These changes will affect virtually all businesses in Pennsylvania. He chairs the Solid Waste Advisory Committee for the Pennsylvania Chamber of Business and Industry and has taken a leading role on behalf of the regulated community in the development and implementation of Pennsylvania's waste regulations. Meloy serves on the Pennsylvania Cleanup Standards Scientific Advisory Board and the Delaware Basin Regional Water Resources Committee. Cassidy will serve as one of the Roadshow's environmental appraisers, offering individual consultation in the area of environmental law.
