LEED, or Leadership in Energy & Environmental Design, is a green building rating and certification system of the U.S. Green Building Council (USGBC), which provides independent third-party verification that building design, construction, and operation employ strategies aimed at achieving high performance in key areas of human and environmental health, such as sustainable site development, water savings, energy efficiency, materials selection and indoor environmental quality. USGBC's annual Greenbuild Conference is the world's largest conference and expo dedicated to green building. Greenbuild brings together industry

leaders, experts and professionals for three days of education, networking, industry showcases, and tours. Greenbuild tours highlight the region's leading sustainable buildings and neighborhoods, providing unique learning opportunities beyond the classroom.

Ms. Gotanda is Co-Chair of the MGKF Sustainability practice and is a LEED® Accredited Professional (LEED AP).
