Presented on “The Migrating Impact of Vapor Intrusion”  
for the ABA Section of Environment, Energy, and Resources**

Philadelphia, PA (May 4, 2015) – Kate Campbell, a partner with the environmental, energy and land use law and litigation firm of Manko, Gold, Katcher & Fox, LLP (“MGKF”) located just outside of Philadelphia, PA, participated in a panel on “The Migrating Impact of Vapor Intrusion” on April 27th. This teleconference was sponsored by the American Bar Association’s Section of Environment, Energy and Resources (ABA SEER), Superfund and Natural Resources Damages Litigation Committee and Environmental Litigation and Toxic Torts Committee. MGKF Partner John Gullace served as the moderator for the program.

Vapor intrusion issues have become increasingly prevalent in investigations and cleanups performed under CERCLA, RCRA and state law counterparts. And with this increased emphasis on vapor intrusion risks at cleanup sites, there is now a trend of plaintiff’s lawyers bringing toxic tort actions for personal injury, medical monitoring and property damage against defendants, even for closed, legacy sites. The panelists discussed the science of vapor intrusion, EPA’s changing regulatory guidance, and strategies for defending toxic tort litigation involving allegations of vapor intrusion into residences and other buildings.
