Hermann Environmental Law Writing Contest. In 2009, he received the Presidential and Congressional Bronze Medals for Community Service for his work with AmeriCorps National Civilian Community Corps.

At MGKF, Trego rounds out a team of 28 attorneys, two technical consultants and two paralegals, and will concentrate his practice on environmental litigation.
