Philadelphia, PA (September 17, 2015) – Christopher D. His presentation, which is part of the RE3 (Remediation + Redevelopment + Results) Conference 2015, was held on Wednesday, September 16 at the Pennsylvania Convention Center in Philadelphia.

Although the process and procedures for environmental due diligence and risk assessment in mergers and acquisitions, real estate transactions, and remediation projects have changed little in 30 years, there is a significant need for improved decision making concerning the environmental risks impacting transactions and projects. Competition for funding is increasing and the timeframe to analyze deals is decreasing. Ball and his fellow panelists introduced sophisticated modeling process tools that can transform qualitative suppositions into quantitative assurances which can facilitate the development of risk mitigation, reduction, and elimination strategies. This session discussed the process and presented real world case studies.
