McCabe, a partner with Manko, Gold, Katcher & Fox, LLP (MGKF), the environmental, energy and land use law and litigation firm based just outside of Philadelphia, PA, will present “Environmental Compliance Issues in Business Transaction” as part of the Pennsylvania Bar Institute’s 21st Annual Business Lawyers Institute. Her presentation will take place Thursday, November 5 at 11:10 am at the CLE Conference Center in the Wanamaker Building in Philadelphia, PA.

Potential environmental liabilities are part of any business transaction. They take the form of ongoing compliance with regulations and permits, exposure to tort claims from contaminant releases and responsibility for site remediation. At this session, McCabe and fellow panelists will examine best practices from both an in-house and outside counsel perspective on how to perform due diligence, how to allocate risk of environmental liability between the buyer and seller, how to ensure that the business can operate in compliance on the day after the transaction, and how planned operational growth or contraction impacts compliance with existing and proposed permits.

At MGKF, McCabe counsels clients on a wide variety of environmental issues, including permitting, compliance and enforcement matters related to air emissions, storage tanks, stormwater, wastewater pretreatment, and hazardous waste. She has assisted clients with environmental auditing, permit appeals, and defense of agency enforcement actions. She has represented clients before the Pennsylvania Environmental Hearing Board, the New Jersey Office of Administrative

Law, the U.S. Environmental Protection Agency, Environmental Appeals Board, and the District of Columbia Circuit Court of Appeals.

McCabe serves as Chair of the Board of Directors of the Pennsylvania Environmental Council, and as the Chair of the Friends of Lemon Hill. She has also been a lecturer-in-law at the University of Pennsylvania School of Law since 2007.
