Philadelphia, PA (March 1, 2016) – MGKF partners Joseph M. Manko, Bart E. Cassidy, Jonathan E. Rinde and Carol F. McCabe, will participate in the 2016 Environmental Law Forum. This annual two-day event draws attorneys, engineers, consultants, professors and scientists to Harrisburg for an update on Pennsylvania environmental law. The firm is a Silver Sponsor of the Forum and McCabe serves as one of the course planners for the event.

On Wednesday, April 6, Cassidy will participate in “*Hot Topics and Advanced Air Permitting*” from 1:45-2:45 pm. This session will focus on the practical application of new regulatory, enforcement and litigation developments to permitting and other strategic considerations concerning air quality law. The revised RACT requirements, changes in NAAQS, the new EPA approach to HAP regulation and even greenhouse gas standards will raise implications for many sources; fossil fuel-fired electric generating units are not the only sources to be affected by this changing landscape.

Later that afternoon both Rinde and McCabe will present concurrent sessions at 4:15 pm. Rinde’s panel will focus on “*Natural Resources and Wildlife Update.*” Rinde and his fellow presenters will examine how

threatened and endangered species are protected and considered during the federal and state permitting process. The program will also include an overview of new upgrades to the Pennsylvania Natural Diversity Inventory environmental review tool.

McCabe will participate on the Planners Roundtable entitled, "*Ethics: When Lawyers Move Between Government, Law Firms and NGOs.*" The panel will engage attendees and encourage their participation.

Manko will moderate a "Super Session" on Thursday, April 7 on "*Federal and State Issues,*" which will run 8:30-10:00 am. He will be joined by EPA Region III Counsel and DEP Chief Counsel, for a look back at the most significant environmental developments in the state and region during 2015. They will also share what they expect to happen during the rest of 2016. Their remarks will include new developments and changes within their respective agencies.
