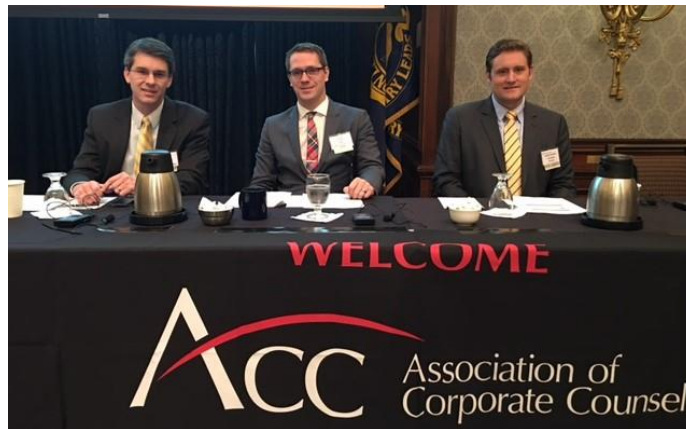

**MGKF's Franey and Daly Presented  
at the Ethics & Compliance Institute of  
the Association of Corporate Counsel Greater Philadelphia**

Philadelphia, PA (December 2, 2016) – Manko, Gold, Katcher & Fox attorneys Bryan Franey and Stephen Daly joined by Christopher Havener, Assistant General Counsel of Employment Law for Aramark, presented "Put Your Best Face Forward: Managing Your Company's Online Presence" at the Association of Corporate Counsel (ACC) Greater Philadelphia's Ethics & Compliance Institute on December 1. MGKF is also a Silver Sponsor of ACC Greater Philadelphia.

The presentation engaged the audience in a discussion of the potential ethical and compliance pitfalls that in-house counsel can encounter when exercising either too much or too little control over the social media presence of a company and its personnel. The various scenarios addressed limitations on company control

over employee social media, ethical implications raised by social media communications during litigation and in-house counsel's duty to collect and preserve evidence on social media during discovery.

Franey is a partner at MGKF and has experience in counseling and representing clients on a range of environmental and energy matters. Over the last several years, his practice has focused on regulatory compliance and transactional matters, particularly in the areas of air and water quality, redevelopment, sustainability, permitting, energy efficiency and renewable energy development.
