2012 ENVIRONMENTAL COMMUNITY SERVICE AWARD

**\$10,000 IN HONORARIUMS TO BE AWARDED ...
CELEBRATING SEVEN YEARS OF RAISING AWARENESS OF ENVIRONMENTAL
CONCERNS WITH SCHOOLS THROUGHOUT THE DELAWARE VALLEY**

**Region-Wide Collaboration Spearheaded by
Wawa, NBC 10 and Manko, Gold, Katcher & Fox, LLP**

Philadelphia, PA (January 17, 2012) – Now in its seventh year, the Annual Environmental Community Service Award will once again be presented by Wawa, NBC 10, and the environmental law firm Manko, Gold, Katcher & Fox, LLP (MGKF). The goal of the Environmental Community Service award is to raise awareness of environmental concerns and to recognize middle and high schools in the Delaware Valley for their efforts in environmental service projects that enhance and improve the quality of life in their communities.

Each year one high school and one middle school receive a \$5,000 honorarium to further their environmental programs. The applications for this year's Environmental Community Service Award are available online at www.wawa.com, www.nbc10.com and www.mgkflaw.com. All applications must be signed by a school official and submitted by Monday, March 5, 2012.

Winners will be announced at a surprise presentation at the top schools prior to April 22, which is Earth Day 2012.

Since the program's inception, a dozen schools in the tri-state area have been recognized for their outstanding programs. In 2011, Charles F. Patton Middle School won for their garden and greenhouse they manage on the school grounds. With their gardens, they were able to donate 50 pounds of vegetables to the local food bank whose facing a 40 percent increase in demand in the last year alone. Father Judge High School was also honored for their wind turbine. The turbine

they built produces 500 watts of power and is used to illuminate a memorial on school grounds that honors school graduates who have lost their lives in service to others.

In prior years, the awarded programs were just as interesting. The winner schools have been Lincoln High School in Philadelphia; Epiphany of Our Lord School in Plymouth Meeting, PA; Interboro High School in Prospect Park, PA; St. Francis Xavier School in the Fairmount section of Philadelphia; Cedarbrook Middle School in Wyncote; Gateway Regional High School in Woodbury Heights, NJ; W.B. Saul High School of Agricultural Sciences, Philadelphia.; Sadie Tanner; Mossell Alexander University of Pennsylvania Partnership School in West Phil; Friends Central Middle School in Merion, PA; and Camden High School in Camden, N.J.

Robb Fox, managing partner of Manko, Gold, Katcher & Fox, LLP and one of the advocates for the award, is proud of the programs they have recognized. “Each year we learn about such impressive programs that are taking place in our area schools. It’s never easy to select a winner when we have seen the incredible efforts by students and faculty over these past several years.”

The individuals who judge the programs are all experts in the field of the environment and science. They are representatives from The Franklin Institute, the Academy of Natural Sciences, the Fairmount Water Works Interpretive Center, Pennsylvania and New Jersey’s Department of Environmental Protection, and Delaware’s Department of Natural Resources and Environmental Control along with someone representing each sponsor -- Wawa, NBC 10, and MGKF.
