## JOSEPH MANKO AND BRENDA GOTANDA OF MANKO, GOLD, KATCHER & FOX, LLP TO SPEAK ON MANAGING THE NEW RISKS OF GREEN BUILDING

Philadelphia, PA (November 24, 2009) – Joseph Manko, a founding partner, and Brenda Gotanda, partner and a LEED Accredited Professional, with Manko, Gold, Katcher & Fox, LLP (MGKF), will present "Green Building Update - Managing the New Risks" at the Pennsylvania Bar Institute's (PBI) 13<sup>th</sup> Annual Law Institute on Thursday, December 3. He graduated magna cum laude and Phi Beta Kappa from Yale University and cum laude from Harvard Law School.

Gotanda has over 15 years of experience in environmental, energy, land use, and health and safety matters. She counsels and represents businesses in regulatory, transactional, permitting, and enforcement matters. Her practice includes green building, sustainability, site remediation and brownfield redevelopment, waste and recycling, water quality and water pollution control, and alternative energy matters.
