**MICHAEL MELOY AND BART CASSIDY OF MANKO, GOLD, KATCHER & FOX
TO SPEAK AT PA CHAMBER OF BUSINESS AND INDUSTRY'S
RESIDUAL WASTE, HAZARDOUS WASTE, STORMWATER MANAGEMENT
AND CLEAN AIR PERMITTING CONFERENCE**

Philadelphia, PA (October 10, 2008) – Michael Meloy and Bart Cassidy, partners with Manko, Gold, Katcher & Fox, LLP (MGKF), an environmental, energy and land use law firm, will speak at the Pennsylvania Chamber of Business and Industry's "Practical Applications for Residual Waste, Hazardous Waste, Stormwater Management, and Clean Air Permitting/ In-Depth Key Environmental Issues Compliance Conference." The conference will take place at four locations on the following dates: Thursday, Oct. 16 at the Holiday Inn Conference Center, Lehigh Valley; Thursday, Oct. 23 at the Four Points Sheraton Pittsburgh North; Tuesday, Oct. 28 at the Radisson Penn Harris Hotel & Convention Center, Camp Hill; and Thursday, Nov. 6 at the Crowne Plaza Valley Forge.

Meloy and a co-presenter will address "Residual Waste Management," focusing on definitions of residual waste; recycling requirements, including biofuels; requirements for residual waste generators; permitting requirements, clean fill policy; waste oil program, and what to do with electronic waste. The presentation will also cover how to balance what you need to do now with the top three recommendations to consider in planning for the DEP's future consolidation of residual waste regulations.

Cassidy and co-presenters will speak on "Federal Air Regulations and Air Permitting Requirements Management," covering Title V permit renewal, including CAM requirements; changes in Federal ozone standards and possible implications; NESHAP update, new source review update and preconstruction permitting requirements; issues confronting minor sources; common air quality compliance issues; Federal and State CAIR regulation; PM 2.5 update; importance of Emission Reduction Credits and creditable emissions reductions; climate change/greenhouse gas emissions and implications for Pennsylvania businesses and the top three recommendations environmental managers should consider in planning for EPA and DEP changes to future air regulations.

Meloy has 25 years of experience in the environmental field. He uses his legal and engineering background to assist clients in connection with a broad spectrum of environmental litigation, regulatory and transactional issues, including shaping and complying with environmental regulatory requirements. Meloy serves on the Pennsylvania Cleanup Standards Scientific Advisory Board and the Delaware Basin Regional Water Resources Committee.
