MANKO, JOHN GULLACE AND MICHAEL MELOY OF MANKO, GOLD, KATCHER & FOX, LLP TO SPEAK AT PA CHAMBER ENVIRONMENTAL LAWS AND REGULATIONS CONFERENCE & TRADE SHOW

In 2005, he was recognized as one of two Pennsylvania Rising Stars in the area of environmental litigation by Law & Politics. Gullace has completed "Advanced Arbitrator Training" jointly conducted by the Chartered Institute of Arbitrators and the International Institute for Conflict Prevention and Resolution. Recently, Gullace was reappointed as Chair of the Lower Merion Township Environmental Advisory Council.

Gullace is a member of the Montgomery County Bar Association and served as Chair of its Environmental Law Committee in 1999, 2000 and 2002, and Vice-Chair of the Committee in 2001. He has been a program organizer and speaker on various environmental topics, including environmental litigation and ADR, for such organizations as the Pennsylvania Bar Institute, the Montgomery County Bar Association and the Dispute Resolution Institute. He is also a member of the American and Pennsylvania Bar Associations. Gullace received his undergraduate degree from Haverford College and earned his law degree from New York University School of Law.

Meloy has a legal and engineering background and represents clients in connection with a broad spectrum of environmental litigation, regulatory and transactional issues. He chairs the Solid Waste Advisory Committee for the Pennsylvania Chamber of Business and Industry and serves on the Pennsylvania Cleanup Standards Scientific Advisory Board. Meloy has taken a leading role on behalf of the regulated community in the development and implementation of Pennsylvania's waste regulations. He is a member of the Delaware Basin Regional Water Resources Committee and has chaired the Agricultural Law Committee of the Pennsylvania Bar Association. He is also a member of the Advisory Council of the Department of Civil and

Environmental Engineering at the University of Delaware. Meloy graduated summa cum laude with a bachelor's degree in civil engineering from the University of Delaware and cum laude from Harvard Law School.
