WINNERS ANNOUNCED OF 10th ANNUAL ENVIRONMENTAL COMMUNITY SERVICE AWARD

**Region-Wide Search Spearheaded by
Wawa, 6abc and Manko, Gold, Katcher & Fox, LLP**

Philadelphia, PA (April 29, 2015) – The two winning schools of the 10th Annual Environmental Community Service Award are the **George W. Nebinger School in Philadelphia and The Douglass School in Wilmington**. Spearheaded by Wawa, 6abc, and the environmental law firm Manko, Gold, Katcher & Fox, LLP (MGKF), the award celebrates a decade of supporting environmental programs that improve the local community. The goal of the Environmental Community Service Award is to recognize schools (6th grade or higher) for their outstanding programs that enhance and improve the quality of life in their communities as well as raise awareness of environmental concerns.

Each school won a \$5,000 honorarium to further their environmental programs. Since the program's inception, 20 schools in the tri-state area have been recognized for their outstanding programs winning a total of \$100,000 to enhance environmental education.

The George W. Nebinger School, located at 601 Carpenter Street in South Philadelphia, was recognized for their entire campaign -- "Go Green – One Team One Planet". The school supports physical health, social health, the environment and an outdoor learning laboratory that is a great benefit to students, families and the community. They are focused on establishing awareness of the Delaware Estuary with various programs. They implemented stormwater infrastructure to reduce runoff and installed a rain garden. Students are responsible for monitoring soil and watering needs and keeping debris out of the rain garden, which is part of a curriculum developed by the Phila. Water Dept. The students are also involved in experiential learning at Phila. Water Works Interpretive Center. Even though they are based in an urban setting, the school has beautiful vegetable gardens and murals, including a mosaic, created by students with a teaching artist from Partner Philly Magic Gardens that depicts the Delaware Estuary. Nebinger focuses on up-cycling projects and recycling of materials as well as the culinary and nutrition curriculum that adds to the value of their food garden.

The Douglass School in Wilmington, classified as at-risk for completing high school, provides educational studies that include therapeutic programs. Students learn transferrable soft skills to build potential for employment through a program called S.a.L.T. – Students-serving- society and Learning Too. It is a multi-level program that includes planting and harvesting vegetables through a partnership with Healthy Foods for Healthy Kids. In addition to working in the garden, the students are involved in cooking by making healthy salads for the school community. They also prepare baked goods for sports program. S.a.L.T. focuses on developing Social Interactive Skills, Community Engagement, Health Awareness, Energy Conservation and Efficiencies, Mentoring and Educational Encouragement.
