They also provided an overview of applicable and proposed environmental laws and regulations to the healthcare, biotech and pharmaceutical industries, governmental enforcement priorities and

discussed ways to minimize exposure for environmental liabilities through strategies such as compliance auditing, due diligence and contractual allocations.
