Philadelphia, PA (December 17, 2015) – Katherine L. She will work with other members of the board to support the SPCA’s mission of putting “human” back into humane animal treatment and advocate on their behalf. The Chester County SPCA was the first open admission shelter in Pennsylvania to achieve No Kill status and serves as the only open admission shelter for both Chester and Delaware counties.

Since joining the firm in 2005, Vaccaro, a resident of Wayne, PA, has concentrated on regulatory matters related to air quality for a range of clients, including petroleum refineries, power plants, chemical

manufacturers, and commercial entities.
