MGKF Partners Meloy and Bender Present at 2017 Pennsylvania Chamber of Business and Industry Fall Environmental Conference Series

Philadelphia, PA (October 17, 2017) – Manko, Gold, Katcher & Fox (MGKF) partners Michael Meloy and Rodd Bender are presenting “Complying with Pennsylvania’s Residual Waste Law and the Residual Waste Reports (PA 26R and 25R) – Update on Hazardous Waste Generators” at the 2017 Fall Environmental Conference Series of the Pennsylvania Chamber of Business and Industry. Attendees will gain a better understanding of what materials qualify as wastes, when recycled materials do not qualify as wastes, what types of requirements apply to hazardous and residual waste generators (including the various forms that residual waste generators must complete), recent changes to the federal definition of solid waste and the hazardous waste generator requirements, and particular requirements and proposals relating to clean fill, waste oil, electronic waste, residual waste from the oil and gas industry, and coal combustion residuals. To provide additional insights for the presentation, Meloy and Bender will be joined at each location by the waste program manager from the relevant regional office of the Pennsylvania Department of Environmental Protection.
