Manko, Gold, Katcher & Fox Nationally Ranked for Female Partners by Law360

Philadelphia, PA (October 23, 2020) –Manko, Gold, Katcher & Fox, LLP (MGKF), the environmental, energy, land use and litigation law firm located in suburban Philadelphia, is pleased to announce that it has been named a <u>Law360 "Ceiling Smasher</u>". MGKF was ranked 23rd nationally for its percentage of women in the partnership based on firms with less than 100 attorneys.

While many law firms' partnership ranks are still dominated by men, MGKF's female partners account for nearly 35 percent of the partnership. Law360's 2020 Glass Ceiling Report found that women make up 37 percent of all attorneys, but just 25 percent of partners nationally. At the top level of a typical U.S. law firm, women account for only 22 percent of equity partners, but at MGKF 38.9 percent of the equity partners are female, which landed the firm in <u>8th place for firms with 20-50 attorneys</u>.

Manko Gold was also one of seven firms in early 2020 to announce that women had taken over as top leaders at their firm. Carol F. McCabe took on the role of Managing Partner January 1, 2020 as the first female managing partner in the firm's 30-year history.

Law360 surveyed more than 300 U.S. firms about their overall and female headcount numbers as of Dec. 31, 2019. Only U.S.-based attorneys were included in the survey. Firms are ranked based on their percentage of U.S. partners, both equity and nonequity, that are women. Law360 ranked firms by examining a variety of factors, including the percentage of partners, both equity and nonequity, who are women; the percentage of associate-level attorneys who are women; and the allocation between those two categories.

"From the founding of the firm more than thirty years ago, the focus has always been on providing exceptional client service and maintaining a firm culture that attracts talent." says McCabe. "We are pleased to be recognized for promoting gender parity and we are proud of the firm's skilled, diverse team."
